DANGEROUS AND PROHIBITED GOODS (QUICK REFERENCE)

Dangerous and prohibited goods may not be carried in passenger baggage for safety and security reasons. Below is an overview and information on typical items and questions.

Only allowed on one's person



1 small lighter or 1 box of matches

Only allowed in carry-on baggage and passenger cabin



Spare batteries/ power banks



E-cigarettes (not allowed to be charged on board)



Heat producing articles / Diving lamps

Prohibited in checked baggage and carry-on baggage



Explosives



Oxygen cylinders



Oxidizing/ corrosive substances



Tasers



Gasoline / fuel paste



Camping gas



Paint / alcohol >70%



Poison/ household chemicals



Battery powered transportation devices (incl. E-Bikes)



Radioactive material



Dry Ice (Carbon Dioxide, solid) > 2,5 kg



Baggage with nonremovable batteries

Prohibited in carry-on baggage



Firearms/ ammunition (see information on page 2)



Sharp/pointed objects



Blunt instruments



Workmen's tools



USA flights/ Powder > 350 ml



- 1. each person is limited to a maximum of 15 PEDs. The operator may authorize the carriage of more than 15 PEDs.

Important for the safe transport of your electric mobility device



In any case:

- The battery power must be isolated
- Protect exposed battery terminals from short circuits, e.g., by taping the terminals, to prevent the mobility device from inadvertent activation
- In case of transport including the battery, please turn off your device completely:
 - Remove the key
 - Deactivate the device using the joystick or an isolation switch or button, or other isolation mechanism as required by the manufacturer for transport
- Transport removed batteries or spare batteries in the original manufacturer's packaging or other strong, rigid packaging



Important for the transport of passenger weapons (firearms & ammunition)

If you intend to take weapons with you on your flight, please note the following about the transport of weapons at K5-Aviation

Passengers are generally not admitted to carry weapons and ammunition on board the aircraft. Both the weapon and ammunition are carried exclusively in the cargo hold. Weapons must be unloaded and securely packed in a solid packaging provided for this purpose, which must be lockable. K5-Aviation may have the weapon inspected by the authorities/police prior to loading.

The weapon must be handed over personally to the flight crew before entering the security area and will only be handed over again outside the security area after arrival.

For the transport of ammunition, it must be ensured that the ammunition is approved/suitable for transport in passenger aircraft (see DGR).

In very specific special cases, there may be exceptions for bodyguards with the appropriate official authorization. In these cases, contact your representative at K5 at an early stage to check and declare.
